### POSTAL BALLOT NOTICE

Dear Member(s),

Notice is hereby given pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment thereof, for the time being in force) ("the Rules"), Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable laws and regulations that the resolutions appended are proposed to be passed by way of E-voting/ Postal Ballot.

The Explanatory Statement pertaining to the Resolution setting out the material facts and the reasons thereof is annexed hereto along with the Postal Ballot Form for your consideration.

In the event the draft resolution as set out in the notice is assented to by the requisite majority by means of E-voting or Postal Ballot (whichever method the Shareholder opts for), it shall be deemed to have been passed as Special Business at an Extraordinary General Meeting. The date of the announcement of result of Postal Ballot shall be considered as the date of passing of the said resolution.

The Board of Directors of the Company has appointed Shri Ajay Suman Shrivastava, a Practicing Company Secretary (FCS: 3489; CP: 3479) as the Scrutinizer for conducting the postal ballot and e-voting process thereto in accordance with the provisions of the Companies Act, 2013 and the Rules made thereunder in a fair and transparent manner. Members desiring to exercise their vote by postal ballot are requested to carefully read the instructions printed in the Postal Ballot Form and return the same duly completed. The duly completed Postal Ballot Form(s) should reach the Scrutinizer not later than 17:00 Hours (IST) on 15<sup>th</sup> March, 2018.

Members desiring to opt for e-voting as per the facilities arranged by the Company are requested to read the instructions in the Notes under the section 'Voting through electronic means' in this Notice.

The Scrutinizer will submit his report to the Chairman or any Director of the Company on or before 17<sup>th</sup> March, 2018. The result of postal ballot (including e-voting) shall be declared on Saturday the 17<sup>th</sup> March, 2018 at the Company's registered office. ## **EXPLANATORY STATEMENT PURSUANT TO SECTIONS 102(1) AND 110 OF THE COMPANIES ACT, 2013**

As per the requirements of Section 102(1) read with Section 110 and other applicable provisions of the Companies Act, 2013, this Explanatory Statement contains relevant and material information to enable the shareholders to consider and approve the Special Resolution set out at item no. 1 of the Notice.

### **Item No. 1:**

#### **The objects of the issue:**

The Company is in the business of manufacturing and trading in gold and studded jewellery. In view of the robust demand and an escalating inclination towards branded products and in order to enhance its market presence, the Company seeks to intensify its existing business operations. The proceeds from the preferential allotment will be utilized for its working capital requirement and for further expansion of its current business setup in terms of production capacity, varied product range, sales and marketing and widening the existing clientele base.

#### **The proposal of the promoters/directors/key management personnel to subscribe to the offer:**

Mr. Ritesh Kumar Sanghi, Mr. Sanjay Kumar Sanghi, Mrs. Pritha Sanghi, Mr. Hanumanthrai Sanghi, Mrs. Sarala Sanghi, Mrs. Bhavana Sanghi, Mr. Tejas Sanghi and Mr. Uday Sanghi belonging to the Promoter and Promoter Group is subscribing to Equity Warrants in the preferential issue. **The justification for the allotment proposed to be made for consideration other than cash together with valuation report of the registered valuer:**

The allotment of equity warrants is made on preferential basis for cash and therefore the said justification is not applicable to the Company.

**Lock-in-period:**

Pre-preferential allotment holding of Equity Shares, non disposal of Equity Shares and lock-in period of the Equity Shares:

- i. The Equity Shares to be allotted on a preferential basis to the Promoter Group, pursuant to exercise of options against each Warrant, shall be subject to 'lock-in' for a period of three years from the date of trading approval for such Equity Shares in accordance with Regulation 78(1) of the ICDR Regulations.
